

Bendigo Marketplace FOTF People's Choice Terms & Conditions

Conditions of entry: Bendigo Marketplace "Fashions of the Fields" People's Choice

Registrations will be available at the Bendigo Cup Fashions on the field marquee on Wednesday October 31st .

1. Method of entry: Contestants agree to be bound by these terms and conditions

Competition opens on Wednesday October 31st and closes on 16:00 Thursday 15th November 2018.

Entrant must have their photograph taken at the Bendigo Cup on October 31st 2018 and complete a Bendigo Marketplace Fashions on the Field entry form to be eligible to enter the People's choice competition.

2. Winner Decision:

The People's Choice Award winner will be determined by public vote through the Bendigo Marketplace website and Bendigo Marketplace Facebook page.
